Cleansing Notice / Appendix 2A

Issue of Shares - Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) (“Los Cerros” or the “Company”) advises that it has issued and allotted 125,000 fully paid ordinary shares (“**Shares**”) upon the exercise of 62,500 unquoted options exercisable at \$0.10 per option on or before 6 April 2022 and the exercise of 62,500 unquoted options exercisable at \$0.02 per option on or before 18 May 2022.

The Corporations Act 2001 (“**Act**”) restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act.  - ii. that investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:
 - 1. The assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - 2. The rights and liabilities attaching to the Securities.
